CONDITIONS AND LIMITATIONS TO THIS CERTIFICATE:

- Repairs, manufacture and modifications of TC 407 and TC 412 highway tanks (including piping) loaded by vacuum or with MAWP greater than 35 psi and 15 psi, respectively, and repairs and modifications of TC 350 highway tanks (including piping) with MAWP greater than 15 psi are not authorized.
- Repairs, manufacturing and modifications of FRP tanks are limited to metal piping.

EXPIRY DATE OF THIS REGISTRATION:

Unless otherwise notified, this registration is valid until the date of expiry indicated above. A new application must be submitted where there is any substantive change in the information given on the application form filed with Transport Canada. Renewal applications should be made at least 90 calendar days before the certificate expiry date to avoid a disruption of your registration status.
